

# DECLARATION on the manner of mandatory customer information for NON-marketing purposes investment services

**Customer** of MBH Bank Nyrt. (Bank), choose the manner of the supply of information from investment service providers to customers pursuant to to he MiFID **legislation** as stated below:

### I. Declaration on information on the website

□ I declare that I have regular internet access and hereby give my consent to the Bank's providing me all the information that may be disclosed on the website pursuant to the applicable legal regulations on its homepage (**website**).

I have been informed that the scope of information referred to above includes especially the following information: prior information form the Bank about investment services, ancillary services, financial instruments, information on costs and related fees, information on the protection of the customers' financial instruments, information on the execution policy, which is included primarily in the Bank's MiFID Product Information and the Business Rules on the Engagement in Investment Service Activities and the Provision of Ancillary Services ("Business Rules on Investment Services") as well as information on certain products produced or distributed by the Bank for key investors.

I acknowledge that if I give my consent to information through the website, I shall be obliged to monitor the information published on the website and to use the calculator(s) made available for me on the website as and when necessary.



## II. Declaration on the supply of other mandatory information<sup>1</sup> (one of the two alternatives must be chosen)

With regard to information that the Bank is not entitled to provide through its website pursuant to the legislation or due to lack of my declaration of consent referred to in paragraph I, I request the mandatory information to be provided to me by the Bank (hereinafter "Information) to be sent on the channel indicated below:

□ electronically (via e-mail or the electronic channel provided by the Bank<sup>2</sup>)

• on paper, sent by post to my postal address provided to the Bank.

I acknowledge that if I opt for information to be provided on paper, using investment services available on the phone or in electronic channels may be difficult, in view of the time required for delivery by post, as I will be able to use certain services only after receiving the information sent by post.

I have been informed that if in future I provide a different e-mail address for the supply of Information to me, the Bank shall consider the e-mail address provided last as applicable and will register that in its records.

I acknowledge that if I have chosen information to be provided electronically, the Bank will send me the respective Information via e-mail or through the electronic channel provided by it (Netbank, Vállalati Netbank, Direct Bank). If I do not have access to the electronic channel provided by the Bank, the Bank may also send me the required information on paper instead of e-mail.

I have also been informed and I acknowledge that when information is sent to me via e-mail, the Bank sends the data and Information (constituting bank and securities secret in certain cases) without any coding or encryption to the e-mail address provided by me. I am aware that data transmission via e-mail may entail risks, the transmitted information may be obtained by unauthorised parties, in relation to which the Bank excludes liability for any loss or damage occurring at the Customer. The Bank's information sent via e-mail shall be deemed communicated when it is sent. I declare that I use the e-mail address provided to the Bank exclusively and that no third party had or does have access to it.

#### Other provisions for sending account statements

If I have access to any electronic channel provided by the Bank (currently: Netbank, Vállalati Netbank, Direct Bank), the Bank shall send me the consolidated securities account and customer account statement via an electronic channel and I shall be obliged to query for them at least once in a calendar quarter.

If I do not fulfil my obligation to make queries or I do not have access to an electronic channel, the Bank shall send me the account statements on paper.

I have been informed that sending account statements also on paper when I have access to an electronic channel **may entail an obligation to pay a fee**, as defined in the List of Conditions.

#### Prior information on fees and costs

I acknowledge that if I choose to receive information through the website, then I must register with my e-mail address referred to above on the website <a href="http://www.mbhbank.hu/">http://www.mbhbank.hu/</a> in order to have access to the prior information on fees and costs.

I have the right to modify the above declarations and my choices included therein at any time and the Bank shall always send/make available to me the Information in a manner stated in my declaration, submitted last in time. With this declaration any previous declaration made by me on the manner of the supply of mandatory information by the Bank on its investment services pursuant to legislation shall lose effect with the exception of the declaration included in the respective annex of the framework agreement on OTC derivative transactions and the treasury framework agreement.
